How is the consumer affected by tax laws and the U.S. economy?

Revenue from taxes collect from all individuals benefit individuals and families by providing services at the government, state and local levels. Without this revenue, society would not be able to function at a civilized manner.

Revenue from taxes benefit individuals and families by:
